Update on status of Foundation Bylaws

The motion at the 2023 AGM to rescind the VSF Bylaws and replace them with "VSF Bylaws 2023" was submitted to Corporate Registries along with the new Bylaws. Correspondence from October 2023 noted that the submission to Corporate Registries used an incorrect form. Further, the definition of "Special Resolution" in the "Definitions" section did not conform to the exact wording as noted in the Societies Act.

Lowen that the Foundation Board resubmits the VSF Bylaws 2023 subject to these conditions: the submission uses the prescribed Form as directed by Alberta Corporate Registry Services; and the definition of "Special Resolution" uses the prescribed wording as directed by Corporate Registry Services.

The Audited Financial Statements are in process but delayed due to many factors. The Board is working with the Administration as well as Alberta Education and a consultant from ASBOA to complete this work as soon as possible. When available, the 22-23 AFS will be posted to the website through a permalink in the Annual Education Results Report (AERR). Members will be notified by email wherever possible when the AFS is posted to the website. Of note, an operating deficit has occurred in each of the last two years. Due to a significant gap between the estimated and actual enrolment on which funding is based, this current year is also projecting an operating deficit.
